9. PRESENTATION(S)

9.1 Informational Presentation on the Palmdale Water District Pure Water Antelope Valley Project. (PWD Engineering Manager Scott Rogers)

PWD Engineering Manager Rogers provided a PowerPoint presentation on the Pure Water Project. Mr. Rogers provided background on the project and explained the difference between the two systems. Director Bishop asked if chlorine needed to be added after treatment, and Mr. Rogers responded.

Engineering Manager Rogers went over the timeline for the project. He stated that we are currently working on the feasibility study for Title 16 funding. Mr. Rogers stated that the demonstration facility would cost approximately \$13 million.

Director Alarcón asked about the grant total and when it would be submitted. Engineering Manager Rogers stated that the grant was in review and that the first-round projects have already been funded. Director Anson spoke about reaching out to Las Virgenes to find out what they did to get the ball rolling. There was additional conversation amongst the Board regarding purple pipe, potable water, and the Pure Water Project. The anticipated completion date is 2028.

10. DIRECTOR REQUESTS FOR NEW AGENDA ITEMS

Director Bishop requested an update on the funding for the AV Pure Water Project.

11. INFORMATIONAL REPORT OF THE BOARD OF DIRECTORS, EXECUTIVE DIRECTOR, AND ASSISTANT EXECUTIVE DIRECTOR

Executive Director LaMoreaux spoke regarding Littlerock Dam, he stated it is still spilling fluctuating with the weather. He expects it to go back up, currently it is at the 8" over the spill and has gotten as high as two (2) feet.

Director Bishop stated that he had a good conversation with Director MacLaren-Gomez regarding smart sprinklers rebate. For commercial the smart controller components have a rebate, a rebate was added for residential Hot water recirculation, soil amendment rebate, and one for a high efficiency sprinklers, and smart controllers, and toilets. He also spoke about a flume that can help monitor usage as well as detecting a leak. Executive Director LaMoreaux stated the information on the Palmdale Water District website. Director Alarcón asked for more information on the rebate program so that she can help spread the word.
